We connect local businesses to project opportunities and provide advice to help local win.

Who we are

Industry Capability Network Victoria, an independent organisation supported by the Victorian Government, has been working for local industry since 1984. We were founded on the principle that local businesses, especially small and medium-sized enterprises, should be given full and fair opportunities to compete for work on major projects, aided by local capability considerations. In turn, this helps create jobs by encouraging industry to first think local, social and sustainable in all procurement decisions.

Funded predominantly by the Department of Jobs, Precincts and Regions, and led by our Board of Directors and Executive Leadership Team, ICN Victoria is the trusted government procurement partner, administering the Local Jobs First Policy and the Social Procurement Framework. ICN Victoria delivers Victorian employment and socioeconomic outcomes, and makes a difference by engaging local industry and stimulating local connections and jobs in Victoria and Australia.

What we do

ICN Victoria provides specialist industry and policy support and advice to help connect local business to project and networking opportunities within Victoria and throughout Australia.

ICN Victoria works closely with the Victorian Government in undertaking local capability and supply chain assessments to support and provide advice for policy.

ICN Victoria is responsible for managing end-toend policy implementation activities, including monitoring and reporting.

Our teams across Victoria work to:

- · activate local industry engagement and connections
- provide advice on the Victorian Government's Local Jobs First Policy and Social Procurement Framework
- · maximise local, social, sustainable and employment outcomes for project opportunities.

With the shared goal of supporting positive outcomes for the Victorian economy, ICN Victoria works across all levels of government and industry to:

- connect local suppliers to their local government authorities and project opportunities, such as precincts, urban revitalisation and community clubs
- · advocate for social and sustainable procurement initiatives to improve social and economic outcomes within businesses and councils
- · assist with the creation of local industry engagement policies and compliance with the Local Jobs First Policy.



Performance highlights

ICN Victoria's activity across the procurement phase is captured in the performance highlights for the reporting period 2021–22. There has been significant growth of projects with Local Jobs First Policy implications and business connections across the Gateway, VMC and our online channels. This shows how ICN is the connecting channel for local business to find the next project and source suppliers to meet local content for major projects.

Understanding our customer and stakeholders' real needs across the procurement journey, we work with them sourcing local content and expanding social opportunities. This is how we help local win.

We measure our own performance using both quantitative and qualitative benchmarks including customer satisfaction, grant agreement performance and financial viability.

Our strategic priorities

Our success and growth are underpinned by our strategic priorities.

People and culture

ICN Victoria cannot exist without our people. Our organisational structure provides an opportunity for staff to step up to more responsibility, providing personal and career growth. We do this by investing in our staff, including five days leave per year for professional development.

Our Culture Code is becoming more visible and embedded within our teams with the launch of 'Salpulse' – a channel for sharing stories and recognising staff contributions.

Data, systems, products and services

Our strategic priority to be recognised as the 'go-to' organisation for local supplier, capability and project insights was recognised when the DJPR supported and adopted our VMC system for reliable project information and measurement for policy implementation.

DJPR mandated the use of the VMC for Local Jobs First Policy reporting of data by all agencies and contractors from 14 January 2022. VMC active user rates has grown by 157 percent.

Recognition of efficient VMC service delivery for government policy performance was seen in the demonstrated success through key partnerships with government to deliver policy implementation solutions including:

- Major Transport Infrastructure Authority and DJPR partnership for data collection, contract management and policy performance insights
- DJPR and Department of Treasury and Finance partnership for Building Equality Policy data collection, policy performance and insights.

Governance and financial sustainability

We secured a four-year grant from DJPR to deliver increased job opportunities and small and medium-sized enterprise participation in government procurement through supporting the implementation of the Local Jobs First Policy. In addition, we obtained funding for the implementation of the Social Procurement Framework.

The agreement began on 1 January 2022 (with completion in 2025) and will be monitored with quarterly and annual reporting.

We have developed a growth strategy for the next three years to deliver our target of eight percent revenue growth. In the reporting year we have gained one percent additional revenue.

As part of our structure reorganisation, our policies are under review and will be completed in the next

Reach and impact

Our systems measurements are in place through standard operational processes, supported by digital platforms and applications such as our ICN website, ICN Gateway, VMC platform, Survey Monkey, Mail Chimp, Google Analytics, Power Bl and Salesforce. In addition, monitoring of our key performance indicators is incorporated into individual workplans.

This year we have significantly grown our audience across channels including VMC, online and social media. Our next focus will be growing the impact and leverage of this audience.

The past year, while challenging, has been exciting and rewarding for ICN Victoria. We have plenty to celebrate, with highlights that include:

- 98 projects worth \$112 billion registered on ICN Gateway
- 5327 expressions of interest on Gateway connecting business to opportunities
- Our support to 1194 projects registered in Victoria with Local Jobs First Policy outcomes
- · A significant increase in our medtech sector capability, including the engagement of a dedicated industry adviser, enabling us to support the successful bid for Moderna's first mRNA production facility at Clayton
- Our supply chain mapping activities to assist with the COVID-19 pandemic recovery effort identifying labour and material shortages
- · Our help to activate the Building Equality Policy with a series of webinars to raise awareness and educate the sector
- · The launch of our VMC Help Centre in late 2021,

which allows us to offer 24/7 online support to customers

- An additional 2701 new VMC users registered
- 12 events, including our return to in-person events at the Formula 1® Heineken® Australian **Grand Prix**

In the future, we look forward to contributing towards Victoria's hosting of the 2026 Commonwealth Games, with the state's regions set to be the focus.

We also recently formally announced our partnership with Victoria University. This provides an opportunity to embed collaboration and industry connections even further, while providing students with business experience through internship and collaborative research programs.

As an extension to this partnership, we will also be relocating to the new Victoria University City Tower Campus, a sustainable building in the middle of the CBD, in January 2023.

During the year, we reviewed and redesigned our internal operational model, and continue to grow strong with a four-year grant agreement with the Department of Jobs, Precincts and Regions, which was confirmed in 2021.

At the heart of ICN Victoria are our people, and through our organisation redesign we have strongly aligned on shared values and purpose. I look forward to activating our full potential while keeping the focus on local industry, and how we continue to help local win firmly at the centre.







Organisational structure

National network

ICN Victoria is part of national network of state and territory offices, linked through our brand, and products and services including Gateway.

We provide support and expertise for procurement and supply chain, providing subscribers with advice across a broad range of industries and local markets.

We collaborate across the network and leverage from each office the expertise required, including sharing a series of workshops on the Social Procurement Framework and Industry Policy Participation.

ICN states and territories also come together to represent the network at national events, including the Indo-Pacific Expo, Australian Manufacturing Week and LandForces.











Value creation

Delivering value for our communities and stakeholders is our priority. Our value can be seen through the growth and engagement of our online communities including Gateway and VMC and through our products and services. Our team's capabilities will support the growth of ICN Victoria, together with our value-based culture that reflects our strategic priorities.

Our people

Our Salpulse channel is a new initiative that provides the vehicle for our staff to recognise and engage with each other as we deliver on our Culture Code.

We have seen a five percent growth in our workforce, and 15 percent of our staff have undertaken skills and training as part of their professional development.

Our communities

Our online communities and networks have grown throughout the year, starting with our new website, which was launched in August 2021 and growing with an average of 900 visits per month.

Making connections through social media channels has boomed, growing by 45 percent throughout the period.

Gateway, the portal connecting suppliers to project opportunities and seen by project and procurement managers, has had over 2000 new registrations. Likewise, our VMC platform has continued in its growth, with over 2700 new users.

Supporting the activation of policies and projects saw 12 events viewed or attended by over 2300 participants; and training was delivered to 850 individuals. We helped 96 local businesses via direct consultation.

Our expertise

Our VMC platform has become the mandated portal for measuring policy and project outcomes by the Victorian Government Department of Jobs, Precincts and Regions.

During the reporting period we launched the Building Equality Policy, which attracted over 600 registered attendees.

Our dedicated industry adviser for the medtech sector is creating strong connections to opportunities in health construction, and our supply chain insights are providing government with guidance for decisions that have supported the COVID-19 recovery.



ICN Victoria supported the registration and delivery of strategic and standard Local Jobs First Policy projects during the 2021-22 period to the value of \$233.7 billion.




Gateway registrations

Assisting SMEs to register on the ICN Gateway platform is one of the tangible methods we provide to support SME engagement on government and private projects.


During the reporting period, 3295 new SME connections were registered on ICN Gateway.



Supported projects

ICN Victoria administers the Local Jobs First Policy on behalf of the Victorian Government through understanding and setting minimum local content targets for key projects. We support project bidders and proponents with identifying and engaging local manufacturers and suppliers in support of their bid response or project delivery.

ICN Victoria offers the same support for private projects through leveraging its ICN Gateway platform and other services to assist with maximising the level of local manufacturer and supplier engagement.




VMC Help Centre

In December 2021, ICN Victoria launched the VMC Help Centre to provide additional online support for Local Jobs First Policy bidders.

The VMC Help Centre provides online support for project bidders with the availability of 24/7, providing guidance to bidders on how to complete their Local Industry Development Plan.

Bidders receive step-by-step support in completing their plans, including a live help centre and comprehensive downloadable FAQs.

During the period January to June 2022, the VMC Help Centre supported the completion and submission of more than 2000 Local Industry Development Plans.




Industry sector analysis

To assist local industry in relation to current and future projects, ICN Victoria is performing industry sector analysis to better understand the level of local industry capability to support project procurement opportunities. We are completing research across existing and emerging industry sectors to understand supply chain capability, constraints, gaps and opportunities for addressing sovereign risk.

ICN Victoria, in conjunction with the Victorian Government Australian Medtech Manufacturing Centre, completed analysis of the Australian and New Zealand medical technologies supply chain.

Desktop research identified 10,000 companies indicating an interest in providing inputs to directly participating in product manufacture or servicing the medtech sector.

The chart below outlines the number of Victorianbased manufacturers across the supply chain.





Stable Engineering West Gate Tunnel Project

Stable Engineering is the fabricator and supplier of anti-bog mats, a product that ensures the stabilisation of large mobile cranes operating on unstable ground during erection of very heavy lifts.

Stable Engineering secured a significant order on the West Gate Tunnel Project, the \$6.74 billion major road infrastructure project linking the Westgate Freeway to Citylink via the industrial area in western Melbourne.

They operate out of the Latrobe Valley and with over 40 years' experience, have over 140 workers and have contributed to over 4000 projects across Victoria and nationwide. Their specialty skills include high pressure parts work, turbine overhauls, process plant installation, pipe spooling and more.

ICN Victoria provided a referral for Stable Engineering based on their 20-year relationship with us, and they won the contract to manufacture and supply approximately \$1 million of anti-bog mats for the project. This order contributed to the West Gate Tunnel Project meeting its LIDP steel commitments and through the scope of the works, 10 local people were engaged to assist in completing delivery of the anti-bog mats.

Stilcon Steel Metro Tunnel Project

Stilcon Steel is a steel supplier for the Metro Tunnel Project, including fabrication, coating and installation of walkway brackets, chequerplate, handrails and installation of acoustic tiles within the tunnel and Anzac Station. The project is estimated to cost \$12.5 billion with an expected completion date of 2026.

Noel Morton of ICN Victoria nominated Stilcon Steel as a potential supplier to this contract, based on ICN Victoria's knowledge of their capability, size of operational facilities and project history. Stilcon's contract secured 12 months work at approximately 40 percent of turnover and around 45 people employed through the project in fabrication and install per month. All content was sourced from Australia, including 1600 tons of steel, 10,000 brackets, 10,000 chequerplate units, 15 kilometres of handrail and 30,000 m² of tiles.

Stilcon Steel is based in Sunshine West with 150 full time employees and has been in operation since 1987. Their other state government funded project works include the Chisolm Road Prison and the level crossing removal works.

Stilcon Steel also supported the set up and continuous output of Borun Trading, a small local Indigenous-owned business run by a young team who specialise in the purchase and distribution of construction materials, plant and equipment.

Viridian Glass Geelong Arts Centre

Viridian Glass is the North Geelong manufacturer that created 220 panes of architectural glass for the \$140 million redevelopment of the Geelong Arts Centre in Little Malop Street.

Geelong Industry Adviser Peter McCracken, working in partnership with Viridian, made the connection with Lendlease and Development Victoria to facilitate work on the redevelopment, assisting the creation of local jobs and growth opportunities for local companies.

At its purpose-built facility, Viridian employs the world's most advanced architectural glass processing equipment; processing, toughening, ceramically printing, double glazing and laminating the glass panes for the Little Malop Street redevelopment. These high-performance glass panes will help the Geelong Arts Centre capture more natural light without emitting radiant heat, maximising daylight and energy efficiency.

The Geelong Arts Centre order represents an exciting new chapter for Viridian and its staff of 75 employed at the North Geelong facility. As well as being a boost for local jobs, having the architectural glass manufactured locally reduces the risk of supply-chain delays. The project is expected to be completed in late 2023.

After years of manufacturing automotive glass, Viridian's North Geelong factory has transitioned into Australia's largest purpose-built architectural glass processing facility.

Latrobe Valley Enterprises providing meaningful employment

Latrobe Valley Enterprises (LVE) works as a social enterprise in Morwell in the Gippsland region, providing meaningful employment for people living with disabilities for the past 54 years.

LVE has 113 employees, 88 of whom have varying disabilities (both physical and/or mental), who deliver a diverse range of products and services, including sign-making, grounds maintenance, facilities management, recycling document destruction, business support, and pick and pack services.

Connectivity with ICN Victoria has been critical to their success. LVE is active across all ICN Victoria's events and utilise the networking opportunities provided, attending regional showcases and industry project briefings wherever possible to make connections with project owners.

"Through ICN, we've won work on the Metro Trains Project, the Cross Yarra Partnership, the Level Crossing Removal Project and the Latrobe Valley GovHub. We were also introduced to Downer Group by ICN and we now have a five-year contract working on a metropolitan roads asset maintenance program in Melbourne. Attending the ICN industry briefings are key, you can't expect the work to be delivered to you, you have to put yourself out there and look for it," said Suzanne Lewis, Interim CEO at LVE.

Using the ICN Gateway, LVE is now seeking work in other states, particularly the ACT. LVE is also using the services provided by ICN Victoria to update their capability statement on Gateway as their services expand and they tender for projects.

The Social Procurement Policy has benefited the company hugely, bringing employees opportunities for meaningful work, financial independence and better social outcomes by experiencing true inclusion in the community. To see their work out in the community, develop their skills and take pride in their work enables them to develop goals for their future.
